


UN/CEFACT

- Development and maintenance of Standards, Recommendations and Tools for trade facilitation, to address the needs of business and governments





- Infrastructure
 - Transport, Routing, Packaging
 - Business Service Interface
 - Collaboration Protocol Profiles/Agreements
 - Shared repository network
 - company profiles, business process models and related message structures




Core Components


- Designed to capture:
 - Business concepts (commonality)
 - Relationship between business concepts
 - Individual pieces (objects) of business information in a context
- Format:
 - Syntax Neutral
 - Building blocks of meta-data
 - Uniquely identified
 - Facilitate multi-lingual support








Business process

What is CEN?

- The European Standards Committee (French acronym)
- One of three European Standardization Organizations, recognized by the EC
- A non-profit association, whose members are national standards bodies (BSI, DIN, AFNOR, etc.)
- Now 30 members EU and 3 EFTA
- Affiliate members new applicant countries
- Creating the European single market, in partnership with:
 - CENELEC electro-technical standards
 - ETSI electronic communication standards
- Providing a ready-made pan-European network



elnv Phase I - Background

- CEN Focus Group report on the standards implications of EU Directive 2001/115/EC published 2003
- CEN/ISSS elnvoicing Workshop phase 1 completed 2006
- Participants grown from 6 to >50
- 9 CWA summarised in two general statements:
 - The invoice is the most important document in business processes
 - However the invoice is not a stand-alone document it must be integrated with other processes to guarantee that business operations can be streamlined and automated.



UN/CEFACT & UBL

- UN/CEFACT and OASIS/UBL Collaboration: Work Plan for 2007
 - Currently covers
 - Supply chain (TBG1)
 - Transport (TBG3)
 - Harmonisation of CC (TBG17)
 - XML NDR (ATG2)
 - Code lists (ICG/TMG/ATG)
- This work is guided by the principles described in the "Cooperation Agreement Between UN/ECE on Behalf of UN/CEFACT and OASIS" (May 2005) and the "OASIS / UBL TC and UN/CEFACT Collaboration Statement" (May 2006).



MoU Between UNECE and OASIS

- The parties will appoint representatives to jointly develop and recommend an OASIS-UNECE-UN/CEFACT project alignment and coordination plan, addressing areas of common technical interest, including:
 - i) Harmonization of core data components, UBL, other business data entity libraries, etc.
 - ii) Naming and Design Rules.
 - iii) Mechanisms for business process specification.
 - iv) Adoption and promotion efforts for the ebXML specifications.
 - v) Identity, addressing and e-signature functionalities with potential for interoperability across UNeDocs, Universal Postal Union practices, and other trade facilitation ID and e-signature instances.



JUBL and UN/CEFACT Collaboration Statement

- Consistent with the Cooperation Agreement between OASIS and UN/CEFACT of June 2005:
 - 1. UN/CEFACT recognizes UBL 2 as appropriate first-generation XML documents for eBusiness.
 - 2. For OASIS and UN/CEFACT:
 - future UN/CEFACT deliverables constitute the upgrade path for UBL, and
 - b) the maintenance of UBL 2.x remains with the OASIS UBL TC
 - 3. In the expectation that UN/CEFACT will produce its own integrated set of XML schemas within a period of three years, OASIS will produce no further major versions of UBL past UBL 2.
 - 4. OASIS will grant UN/CEFACT a perpetual, irrevocable license to create derivative works based on UBL.
